The "Hoosier Rewards" contingency program is available to riders in all classes listed below that have a minimum of 10 riders competing in the class. Contingency awards are available to the Pro and Pro-Am classes which include: Youth 200/300 C, Youth 200/300 B, Production Stock C, Production Stock B, Production Stock A, 25+ Open, 30+ Open B/C, 30+ Open A, 40+Open, Women's Open, 4 Stroke C, 4 Stroke B, 4 Stroke A, Sport 15+, College Boy, Open C, Open B, Open A, Pro-Am, and Pro.

PROGRAM REQUIREMENTS:

1. Rider must finish in first or second place using Hoosier ATV MX tires on all four corners.
2. A minimum of two (2) Hoosier decals must be displayed on the ATV.
3. Rider must have New England ATV MX Series official sign this form verifying requirements #1 & #2 have been met.
